Tuition Payments

Tuition payments are due on the 1^{st} of each month. Tuition Statements will be generated and delivered on the 15^{th} of each month via email and your payment will be due on the 1^{st} of the next month.

If your tuition payment has not been received *two days* after the due date, (the 3^{rd} depending on the month; or the following Monday if that day falls on a weekend), you will receive a phone call from the treasurer reminding you of your payment. *Four days* after the payment due date (5^{th}), you will receive some communication (phone call, message left, email, etc.) reminding you of your payment.

At the time of the reminder, you will be allowed to make a **special arrangement** for paying your child's tuition and other fees. This arrangement will be spelled out in writing, and you will be asked to sign indicating that you will keep the agreement made. If you keep the agreement as promised, you will be allowed to make another arrangement in the future, as needed. If this agreement is not kept, you will not be allowed to make other arrangements in the future.

If, for whatever reason, you decide not to make an arrangement at the time of the phone call, your child will be allowed to remain in school for up to 5 days after the phone call. After the 5th day, which at this point in the process, on or about 11th day of the current month, your child will not be allowed to return to school until his/her tuition is paid and made current. These policies have been in effect since August of 2015 and this letter serves as a reminder of the expectations we have financially at V. Lindsay.

As always, you may petition the Special Committee on enrollment if there are extenuating circumstances. The committee will decide when and under what circumstances your child may return to school.

Bounced Checks

Effective immediately, there will be a \$30 bounced check fee for all checks returned NSF. This fee will be added to your monthly statement. We will no longer accept personal checks from a family who has had **two** checks returned NSF. Instead, we will accept money orders or certified checks.

Delinguent Tuition from 2018-2019

After careful prayer and discussion, we have decided that **ALL** outstanding tuition must be caught up by **August 10**, **2019** in order for your child to return for the **2019 – 2020** school year. As always we are willing to have conversations about any previous payment arrangements you have made and have been following. However, for the financial health of the school we must ask all parents to bring their outstanding accounts current.
